The Nautical Flea Market has been scheduled for January 30 & 31 2010, at the Community Park in Pompano Beach. The park is located at 820 NE 18<sup>th</sup> Avenue (just west of Federal Highway between NE 6<sup>th</sup> & NE 10<sup>th</sup> Streets). The event will be open (rain or shine) to the public, with an admission fee of \$5/person. Admission is free to anyone under 12 years of age with paid adult admission. Event hours on Saturday are 8 am to 5 pm and on Sunday from 8 am to 3 pm. **No pets will be allowed in the Park.**

**SPACES AND FEES**

Outside spaces are 10' x 20' for merchandise. There will be 15' x 25' spaces available for boats and trailers only. The cost is \$150.00 for the first space and \$100.00 for each additional space as outlined on the application form. **There are no refunds.**

**SPECIFICATIONS AND CONDITIONS**

The dealer must have marine-related items. The City reserves the right to reject those items that do not meet these conditions. **FIREARMS, STUN GUNS AND WEAPONS ARE PROHIBITED.** The sale of any spear-fishing weapons or projectiles of any type to minors is prohibited. You must provide your own booth preparations. Bring your own tables, counters, chairs, tents, shade and/or weather protection, etc. Police security will be on site Friday and Saturday nights.

**If you have a vehicle on site during the show, it must fit inside your allotted space.** You may need to purchase additional spaces to accommodate your vehicle, trailer, display, etc. The vehicle, trailer, etc. must remain in your space until the end of the event on Sunday at 3 pm. No vehicles will be allowed to enter or exit for any reason after the gates are closed on Friday. These conditions will be strictly enforced – By Order of the Fire Marshal.

**You will be contacted approximately one month prior to the event with your space assignment & set up time. Set up will only be on Friday, January 29 from 8 am until 6 pm. Due to the change in park layout and event growth, we cannot guarantee an exact location.** Spaces are assigned at the discretion of the promoter. Returning vendors' spaces will be in the same vicinity if requested. Your cooperation is appreciated.

To reserve a space, complete & sign the application and release form. Mail the forms immediately to the address at the end of this document with payment in full. Spaces cannot be assigned without a completed application, release form & payment in full. **Make checks payable to The City of Pompano Beach.**
